Working Collaboratively to Support Those in Crisis

The Vancouver Police Department plays a role in advocacy and collaboration with Health and Government. Data has identified the 'mental health crisis' and supports the need for change including program specificity. As system and cohort data becomes available, it identifies program effectiveness and informs our response. This presentation will discuss the ongoing projects to support those in crisis.
